

# Mendocino County-Wide Net Script

Updated December 2024

QST, QST, QST. This is (your call sign) net control for the Mendocino County Amateur Radio Communications Service. This is the McARCS County-Wide net. My name is (your name) and I am located in (your town).

The purpose of this net is to provide a communications network for amateur radio operators in Mendocino County to prepare for and practice for disaster and emergency communications. This net connects the various local nets in the communities or towns in the county.

This is a directed net. Please do not transmit unless authorized to do so by net control.

Initial roll call will be by local community net name. If there has been a local community net in the past week, the net control operator for that community should answer the roll call. If the local net control operator is not available, any amateur operator from that community may check in for that community net.

Please answer with your community net name and call sign only and give me time to log you in. DO NOT give a further report until acknowledged by net control.

When responding, please wait a little bit after pushing the PTT bar to allow the links in this system to become established before you start to talk. Please use the standard phonetic alphabet when voicing your call sign.

If you have an announcement to make to the net, say so when asked for your report. I will not ask you for an announcement to save time.

Please do not follow another station checking in until requested by net control. Please use the standard phonetic alphabet when voicing your call sign. I will not ask you again for an announcement or traffic. Any "Plus 1's" will not be logged.**

**Break. This is (your call sign). (unkey for just a bit and allow the links to reset)**

**Suffix beginning with the letters A, B, C, D, or E; Alpha through Echo, come now**

**Thank you all for checking in and being prepared for disaster communications. In the event of a perceived emergency or disaster, it is suggested that all amateur operators check in with their local nets first and then check this linked repeater system, particularly every hour on the hour.**

**This net will meet again next Wednesday at 7:30 PM on this linked repeater system. The net control station next week should be (station) from (community). This is (your call sign) net control. The McARCS County-Wide net is now closed.**
